

## Claim your Groceries FAQ's

1. **Do the receipts have to be mailed in by a certain date? Before the end of the month, or before the end of the next month?**

The receipts and voucher must be postmarked on or before the last day of the month. For example, your January receipts and voucher must be sent out by January 31st. You should receive your gift card within 10 to 12 weeks from the day you send your voucher and receipts.

2. **When do I have to register my certificate?**

You should register your certificate as soon as you can because you cannot collect receipts until the following month. If you wait until October to register then you will not be able to collect receipts until November.

3. **I registered online, do I need to send in my certificate?**

No, you only need to save your receipts and send in the voucher and receipts for each month.

4. **Do we need to mail in original receipts, or can we provide photocopies?**

We only accepted original receipts, we don't accept photocopies, scanned, fax.

5. **I tried to print/download my vouchers but only 1 voucher printed out, where are my other vouchers?**

Your future vouchers can be printed out by returning to the site and entering your certificate passcode/pin in the registration area during the following months. For example. If you registered your certificate in February, 2009. Your March, 2009 voucher will be printed out. Then you can return to the site in April to print out your April, 2009 voucher, and continue each month for the duration of your redemption period.

6. **How do I contact customer service?**

7. **How long does it take for my giftcard to get to me?**

Please allow 10 - 12 weeks for your giftcard to be received. Please view our [redemption timeline](#).

8. **Can I submit receipts for multiple purchases I made on the same day?**

You can not have multiple receipts dated for the same day. One receipt totaling \$100 or more is acceptable.

9. **Should I start saving my receipts when I get my certificate?**

No need to collect receipts, you must register first. Once you have completed registration your redemption process will begin the 1st of the following month.

10. **Can I submit receipts from other locations besides my preselected grocery store brand?**

No. We are a loyalty program. You must remain loyal to your chosen store for your entire redemption period.

**11. What happens if the brand of groceries I want to use is NOT on your list of cards?**

Then simply choose "Other" and type the brand in the box below that question.

**12. Can the \$100 worth of receipts include other things I buy at the stores besides groceries?**

Yes, but at least 50% of each receipt must be for groceries.

**13. What happens if the receipts do not print the name of the store?**

Please write the store name on the FRONT of the receipts at the top. Make sure that it is legible. Please write the retail name on the FRONT of the receipts at the top. Make sure that it is legible.

**14. What kind of items qualify for 50% of the receipts for groceries?**

Foods for the household to eat, such as: Breads, cereals, fruits, vegetables, meat, fish, poultry, dairy products, etc. You can also purchase seeds and plants which produce food for the household to eat. Also pet food

**15. What items can be purchased towards the non-grocery portion?**

Anything the store sells can be used towards the non-food portion of the receipt, supplies such as: soaps; paper products; vitamins; medicines; prescriptions. Please make sure that this is 50% or less of each receipt.

**16. What happens if I do not spend \$100 on groceries during a calendar month?**

Then you would not be issued your \$25 gift card for that month. The underwriters of the program require that we submit all grocery receipts each calendar month and therefore you cannot combine 2 months of receipts to submit them as one. You must spend \$100 on groceries per month.

**17. Can the \$25 gift cards be used as part of the \$100 worth of groceries spent during the month?**
